Primary users for public safety training:


- Fire/Police/EMS Agencies

The Countryside Fire Protection District is seeking a land transfer agreement with IDOT for approximately 34 acres that was previously earmarked for the Rt. 53 extension. This property shall be utilized as a future Regional Public Safety Training Facility to benefit multiple agencies and jurisdictions.

OTHER BENEFITS OF REGIONAL PUBLIC SAFETY TRANING FACILITY

- Coordinated training with different public safety agencies that typically respond to emergencies together
- Potential location for local/community college / high school tech campus fire/law enforcement training
- MABAS and SRT partnership to allow for centrally located deployment of resources
- Location is not near major roadways or neighborhoods and would not be obtrusive to the community
- Will benefit local hotel and food industries by attracting students from across the region

GOALS AND BENCHMARK FOR TRAINING FACILITY

- Work with local communities and legislators to support land transfer from IDOT
- Land-use survey and conceptual plans with specialized architect using funds on hand
- Governance and leadership structure established
- Determine cost modeling for membership to the Regional Public Safety Training Facility
 - To be self-sustaining from existing tax body dollars
 - · Not for profit
- Seek local, state, and federal grants to help offset construction, with environmental sustainability as a major initiative
- Phase 1 construction would include a large concrete driving pad to allow for large vehicle driver training without damaging local asphalt roadways and/or parking lots

HOW DOES IT EFFECT THE FUTURE ROUTE 53 GREENWAY PROJECT?

Property location is East of the Greenway Project; therefore, should not interfere with the main pathway.
